Workplan actions may include methodologies, tools, training, pilot projects, workshops and policy campaigns.

The ISC has convened the following coalitions to accelerate industry's impact on:

Climate Action

To accelerate climate action in every town, city and region through a place-based approach.

Progressing a system, networked approach to accelerating decarbonisation focusing on towns, cities and regions rather than leveraging the knowledge and work undertaken at an asset, sector and material level.

Resilience

To accelerate systemic resilience so that infrastructure can enable thriving lifestyles, communities and nations, now and into the future.

Resilience in infrastructure is not just about protecting the built forms but ensuring that the service the asset provides will remain flexible, agile and resilient through the shocks and changes of the coming century. It is about building resilience in a systemic way.

Circular Economy

To accelerate the transition to circular business models and economies in infrastructure.

This coalition will complement and align existing progress in circular economy supply chains and initiatives, by focusing on the 'economy' of circular economy and looking at how to integrate the infrastructure network of systems to drive circularity through business models and local economies.

Modern Slavery

To accelerate the eradication of modern slavery from the infrastructure supply chain.

This coalition will build awareness and understanding within the industry, as well as work with the supply chain to identify risks and red flags. The coalition will develop mitigation and remediation strategies while driving action to eradicate modern slavery.



What can you expect in the first year?

The first year of the coalition will scope the issue and set up the structure of the coalition and workplan. During this time the coalition team will meet regularly, at a frequency determined by coalition members, to discuss the focus and angle of the key issue being addressed by the group, ultimately deciding on the plan for greatest impact.

The ISC commits to delivering promotional and positioning benefits over the first year of the coalition.

Coalition Round Table	Minimum 1x Coalition Round Table per annum (hosted by a coalition member at their offices)* with the option to run a larger event at a member location if preferable. This opportunity may double as a Ministerial Round Table if the opportunity exists. Members of the relevant coalition would each have their logo featured in all associated marketing and comms. *Note: venue and catering at the coalition member's cost
Quarterly Progress Update	Quarterly progress update on each Coalition's status in the ISC Newsletters (Stay Up To Date & the ISAP newsletter). All coalition member logos included.
Social Media	Coalition member logos featured with aligned social media content published by the ISC throughout the year (predominantly LinkedIn).
Website Feature	A new coalition's tab will be added to the ISC website for each coalition to report on developments/research/papers etc. All coalition member logos will be included, and any papers published will be acknowledged.
Exhibition Space	With appropriate notice, each coalition will be provided with a no-cost exhibition space at the Annual ISC Connect Conference in Australia and Aotearoa New Zealand; all member logos will be featured. *Note: does not include conference ticket costs.
Speaking Opportunity	Where appropriate, at the Annual Connect Conference in Australia or New Zealand each coalition will be provided with a 45-minute opportunity to undertake a deep-dive session during a break period. Each coalition and their members will be heavily promoted in the pre-conference marketing materials and during conference. *Note:does not include conference ticket costs and presentation content must be at a suitable stage of readiness to be more widely communicated.
Annual Report	Each coalition will be provided with the opportunity to publish an end of financial year Coalition Report as part of the Annual ISC Impact Report.

Case-study - Modern Slavery Coalition

Established in response to the Australian Modern Slavery Act 2019, the ISC Modern Slavery Coalition brought together organisations in the industry to understand how to respond to the new requirements under the Act.

The Coalition worked together to understand the requirements for the legislation and determine the best way to deliver modern slavery statements, and the risks and opportunities for business and industry. Understanding the risks and opportunities for business and industry. Supported by human rights experts the Coalition quickly deepened their understanding of Modern Slavery, risks within the supply chain, and opportunities to build capacity to better address this issue.

Over two years of working together, the

Coalition moved from a workplan focused on compliance into one that is proactively looking at ways to address modern slavery, and ultimately eradicate modern slavery from the supply chain in the Australian Infrastructure Industry.

The Coalition continues to meet regularly, discussing developments in modern slavery, legislation, and work towards delivering a structured workplan with dynamic tools.

Examples of outcomes delivered by the Modern Slavery Coalition include:

- Awareness building webinar delivered to ISC Members and suppliers, designed to deepen the understanding in the industry of Modern Slavery and the risks in the Supply Chain.
- An Impact Note aligning IS Rating Scheme credits to Modern Slavery

- A comprehensive document which outlines credits in the IS Rating Scheme where Modern Slavery outcomes from projects, and recommended best practice principles, can be applied.
- Scenario based training. Providing practical advice and experience on addressing modern slavery allegations in the workplace.
- Expert presentations. A series of experts delivered presentations to build knowledge on a range of topics or themes for the coalition.
- Development of supply chain risk tools to support small to medium enterprises better understand, address and communicate modern slavery risks.
