
### Background

- The IS v2.0 Planning rating tool is designed for infrastructure projects from the strategic options assessment to tender phases
- Only Planning phase sustainability rating scheme in Australia and New Zealand (and internationally)
- Currently **18 beta projects** using the v2.0 Planning rating
- First certified Planning project achieved a Silver level award (against a contractual requirement for Bronze)






### **ISC Member Survey**

### **ISv2.0 Planning – Proponent Feedback**

"Adoption of the IS V2.0 Planning rating on the BORR project proved to be both a **significant challenge** as well as an **important driver of sustainable outcomes**.





- $\checkmark$  Development of credit criteria for the following in progress:
  - Detailed Planning: 30 credits (current)
  - Strategic Planning: 7 credits
- $\checkmark$  Consideration of carbon throughout the planning phase.
- Components related to strategic tool implementation, transition from strategic to detailed and scalability.






# **Key Elements for the Detailed Planning tool**

- 1. Builds on current Planning Rating tool with:
  - Incorporate IS v2.0 Planning beta rulings
  - Removal of strategic planning phase requirements from credits
  - Balance between the work required, evidence available and the potential for beneficial outcomes in the Planning Phase
  - Removal of aspects which best sit in Design & As-built phases
  - Incorporate key decisions and relevant changes from the IS v2.1 D&AB TM review
- 2. Carbon explicit in the business case (Ecn-1) and considered more widely across the scheme
- 3. Options to make the Detailed Planning Rating tool more scalable
- 4. Transition from Strategic to Detailed






# **Key Elements for the Strategic Planning tool**

- 1. Selected credits (seven):
  - Integrating sustainability (Lea-1)
  - Strategic context (Pla-1)
  - Options assessment (Ecn-1), Equity & distributional impacts (Ecn-3), Benefits mapping (Ecn-5)
  - Resilience planning (Res-1), Investigating Environmental & Social Impacts (Imp-1 – new)
- 2. Schematic outlining linkages and flow of strategic planning credits
- 3. Carbon in the business case (Ecn-1) and to be considered more widely across the scheme
- 4. Mandatory credit proposed Ecn-1 Options Assessment
- 5. No materiality assessment; no scope outs
- 6. Proposed Pilot for Strategic Planning Rating tool
