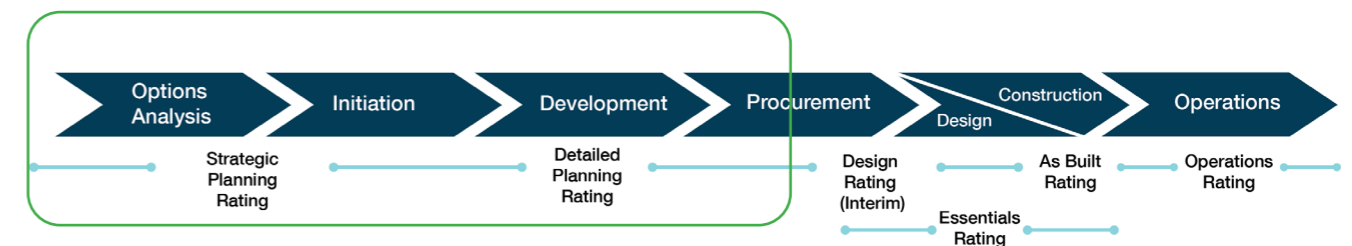
What is IS for Planning?

IS for Planning training explores how, by taking into account the whole-of-life impacts of decisions made in the Planning phase, the Planning rating contributes to sustainability outcomes achieved in the design and construction and operational phases.

This course will provide participants with the necessary skills to apply the IS Planning Technical Manual and supporting Guidelines from initial problem identification through to procurement for design and construction.

The Infrastructure Sustainability (IS) Rating Scheme has been designed to help infrastructure deliver the best possible environmental, social, and economic outcomes.

There is an IS Rating tool to independently assess and reward sustainability outcomes at each phase of the infrastructure lifecycle while also driving outcomes from one phase to another.



Steps to become an ISAP:

1. Register for and complete the CORE training course, IS Rating Skills.
2. Register for the STANDARD training course relevant to the lifecycle stage you work within.
3. Complete the STANDARD training course including end of course test & certificate.
4. Complete the ISAP accreditation exam.
5. Maintain your ISAP accreditation annually.

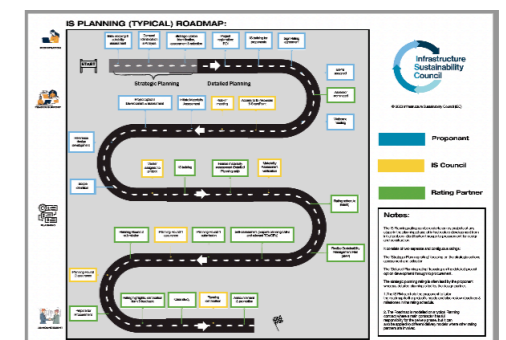
